Statement from Elisabeth MacNamara, President, LWVUS

The League of Women Voters joins with all Americans in expressing our shock and dismay at the tragic shootings in Tucson last weekend. We express our deep sorrow to the families of the victims, and offer our sincere hopes for the recovery of Representative Giffords and the other survivors. We applaud the courage of the individuals, thinking they were just out for a Saturday conversation, who took immediate action to help the injured and end the rampage.

What can we make of this madness, this senseless act of violence? And terrible though this event was for all of us now, what might the long term effects be? Will it make public figures - politicians, media figures, celebrities - more mindful of the potentially harmful impact of their angry words - or will everyone continue to put their own agendas first, without regard to the climate they create? Will it make the public more trusting of the patriotic motivations of their elected leaders - or will respect for them be further diminished? Will it make our elected leaders more willing to reach out to meet and hear from their constituents directly - or will it reinforce the growing gap between voters and those they put in office? Will it allow Americans to feel comfortable and welcome in the public space - or will they conclude that it is safer to stay home and drop out of the conversation? It is clearly time for each of us to consider these issues, individually and as a community.

For 90 years, the League has worked to facilitate the civil exchange of different points of view, to bridge the gap between the voters and the elected, and to help improve the functioning of government. We hope that moving forward our nation will come together to foster and strengthen the very essence of our representative democracy: government of the people, by the people, for the people.

Education News

In the first Fresno Unified School District Board meeting following the winter vacation, the major agenda item was Governor Brown's budget proposal. This calls for major cuts in state programs but keeps K-12 budgets at last year's level. The Governor proposes an election to approve extending temporary tax increases to help balance the budget. Assuming that the extensions are put to a vote and that the voters approve them, the impact on FUSD's coming year budget will still involve a cut of \$30 million (about 5% of the budget)—the remainder of the \$115 million reductions in State funding that have been phased in over the last few years. If the tax extensions are not approved, the District may have to absorb a cut of as much as \$80 million next year.

These local discussions exist against a background of financial hardship around the country. All states have experienced challenges to their finances and to their education budgets. The recent Nation's Educational Report Card reports on the adaptations that States have made and the flow of federal stimulus dollars into the states to help them avoid major layoffs in the schools for the last two years. Those federal fund allocations ended in September, and there is no promise that another round will be coming.

The report did not find major policy or finance changes in the states in re-

sponse to the recession. California has merged funds from numerous categorical programs into general district allocations. Ten states have removed state-level restrictions on the length of the school year, week and/or day.

Against the background of reduced funding and financial stresses, the Report Card on our Nation's Schools was not encouraging. Although there has been some progress in initiating important educational reforms, the overall national grade was a C, about the same as last year. California had an overall score of C, 30th out of the states.

The report card graded the states in 6 major categories:

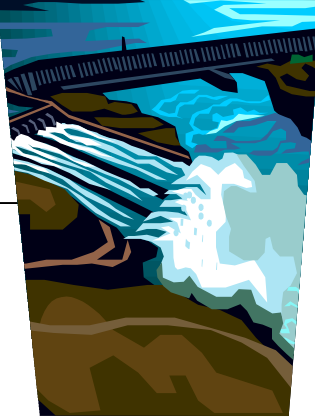
- ◆ **Chance for Success**—an evaluation of 13 indicators spanning early childhood to adulthood including preschool opportunity, school performance and educational and workforce attainment
- ◆ **K-12 Achievement**, which evaluates multiple testing results
- ◆ **School Finance**
- ◆ **Standards, Assessment, Accountability**
- ◆ **Transition and Alignment** assesses state progress in implementing state policies and regulations
- ◆ **The Teaching Profession.**

Each of these is broken down into sub-categories. California's scores follow:

LWVF has worked diligently over the last six months in concert with League positions on good planning principles, water resources, and ag land preservation while addressing the Friant Community Plan, Lost Lake Master Plan, and Friant Ranch specific Plan.

LWVF joined other environmental interests in January to lobby the Board of Supervisors for modifications in the policies of the proposed Friant Community Plan to allow the Lost Lake Master Plan to proceed as independently as possible. Member Radley Reep has gathered over 6000 pages of information relating to planning documents, environmental reviews and comments for the Friant Area. This has been invaluable in working with County staff and speaking to Supervisors. Member Bob Merrill has been a strong voice for water issues concerning the siting of the waste water treatment plant for Friant Ranch and water

resources for the development.

The county of Fresno's General Plan calls for preparing a regional plan for the Friant area. League urged the completion of that regional plan in order to evaluate the development now approved on both sides of the San Joaquin River as well as planning for river restoration and the Parkway before approval of any other development in the region.

The Friant Ranch Specific Plan's January 2011 draft Environmental Impact Report said that the loss of agricultural land to development could not be mitigated; but League pointed out that the County can require the developer to place like ag land in permanent ag land easements for ag land displaced by Friant Ranch.
